

Getting to the Lock # 1 site

Oneida Street gives the best access to the Lock #1 general area. Oneida Street runs South of downtown Appleton's College Ave. There is a traffic light at Lawrence St. and another at Prospect Ave. The Oneida St. Skyline bridge then passes high over the Fox River and the small access road alongside the navigation canal leading to the lock site. Turn left at the traffic light at the South end of the Skyline bridge and onto Olde Oneida St. The gravel access road starts at South end of the Olde Oneida Street drawbridge across the street and just West of the Between the Locks Building.

Drive North over the drawbridge to park and walk back to the Access road.

- We will have a corridor that bridges the past (history) with the future (recreation and economy). We will bike and canoe the Heritage Parkway and spend some money along the way while celebrating our heritage.

Water Trail Beginnings

With a gift from Neenah Paper Company, we are able to facilitate the design and creation of portages around Lock 2 and 3 on the Fox River in Appleton. Funding for the portage around Lock 1 is in progress and Lock 4 portage will be part of Phase 1 of the Residences at RiverHeath. We are excited to start this project as the first step in working toward a Water Trail. A Water Trail is a route along a river or across other bodies of water set for people using small beachable boats like kayaks, canoes, day sailers or rowboats.

We plan to ask the Fox River Navigational System Authority to approve our project at their September meeting, as the trails will be situated on their land. We will then secure contractor bids or contractor partnerships to design and build the portages. Work is projected to begin in the spring of 2009, and should be completed and ready for use by late summer. A special thank you goes to Neenah Paper Company and RiverHeath for their generous donations allowing this first project of the Fox-Wisconsin Heritage Parkway to commence.



Park 2 Park Paddle

The Northeast Wisconsin Paddlers (NEWP) with the Fox-Wolf Watershed Alliance (FWWA) sponsored the 7th Annual Park-to-Park Paddle from Neenah to Appleton. With the assistance of official escorts, fellow paddlers and favorable weather, all enjoyed another safe and fun paddle event. According to the registration information, 209 participants - 87 female (45.3%) and 105 male (54.7%) with an average age of approximately 43 years took part in this years outing. A new record for the number of boats in a single "lockage" was set this year, 169 boats were counted.

Friends of the Fox sponsored the "lockage" fee and Outdoor Outlet supplied the participants with great dry bags. Local law enforcement and emergency service teams supplied both on-water escorts and on shore logistics assistance.

The day of the P2P was a perfect paddling day. Light winds came up as the paddlers entered Little Lake Butte de Mortes. The paddlers adjusted to winds by moving to the leeward side of the lake and paddling the west shore. The paddlers finished the day with food supplied by the Appleton Yacht Club.

Next years' Park-to-Park Paddle is scheduled for July 25, 2009 (information collected by Greenways)

Fox Locks Restoration Progress

Harlan Kiesow, CEO of the Fox River Navigational System Authority reports the restoration of the Fox River Locks is proceeding on schedule. The four locks in Appleton were completed in 2006 and the Cedars lock completed in 2007. By the end of 2008 the guard lock, middle lock and combined locks in Little Chute will be completed. Also, the one mile long levee rebuild in Little Chute is nearing completion and will be able to accommodate a proposed recreation trail for the Village of Little Chute. According to the current plan the five locks in Kaukauna are scheduled for restoration in 2009. This schedule is being re-evaluated because of a potential complication in rebuilding Kaukauna lock #1. The rebuild may potentially require a two year work schedule for the five locks.

The Appleton and Cedars locks were operated briefly this spring until dangerously high waters required closure. These locks were scheduled to be closed in July because of the College Avenue Bridge construction. While the locks are proposed to reopen for operation on August 1 of next year the opening may be postponed pending the bridge completion. Likewise the Little Chute locks may not be operated until the spring of 2011 because of bridge reconstruction on the Little Chute canal. The old lift bridge connecting to Island Park will be removed and replaced. While on an accelerated design and construction schedule the bridge may not be finished until the end of 2010. The three locks in DePere, Little Kaukauna and Menasha will continue to operate as usual with this navigation season ending on October 5th.
