Year End Annual Renewal Letter

Dear Friends of the Fox Members and Supporters,

Friends of the Fox would like to thank you for your generous support in 2014! The accomplishments we have achieved to date would not have been realized without your help. In the past year, the committed group of volunteers serving Friends of the Fox has generously donated their time and talents, as we have supported the following projects and organizations:

- Hosted an Annual Meeting at Riverview Gardens providing information to members regarding the lock restoration project.
- Provided buoy placement and removal of buoys with a new buoy barge between Appleton Lock 4 going through Cedars Lock in Little Chute.
- ♦ FOF has continued input with the Rapide Croche haul over committee as they work to take the next steps required to implement the Aquatic Invasive Species (AIS) barrier, at the Rapide Croche Transfer Station.
- We have prepared a Chart Book for boaters that provides trip planning information through the re-opened locks, from Lake Winnebago to Little Chute. We are pleased to have received a grant, generously donated by the *Bemis Corporation*, that will allow us to publish a second edition of the chart book which will extend from Lake Winnebago to the bay of Green Bay.
- FOF has partnered with municipalities and other non-profit organizations in all the above endeavors, and will continue to do so in support of the Fox River waterway projects.
- ♦ Partnered with Fox River Environmental Education Alliance (FREEA), as Friends of the Fox has moved our office and meeting place to the FREEA Monte Alverno site, to provide support to FREEA. We feel this will also allow FOF more opportunities to interact with local river oriented groups.
- Partnered closely with Fox-Wisconsin Heritage Parkway, focusing on navigation through the entire lower Fox River, an integral part of the vision of FOF. We also continue to support the restoration of the Lock House at Little Chute.
- We have supported Fox River Navigational System Authority as they continue to make great strides in rehabilitating more of the five Kaukauna locks.

We are also accepting contributions to the *Unlock the Fox* fund at the Greater Green Bay Community Foundation, Community Foundation for the Fox Valley Region, and the Oshkosh Are Community Foundation. All donations so designated for that fund will be specifically dedicated to restoration work on the remaining locks, and are tax

deductible.



Fox-Wisconsin Heritage Paddle

13th Annual Appleton Locks Paddle Highlights



Living history, unseasonable warmth and the promise of eagles - all trimmed in fall color - made for a perfect combination to draw a crowd to the last Fox-Wisconsin Heritage Paddle of the season.

194 paddlers took to their kayaks, canoes and stand-up boards to tour the four Appleton locks Saturday, Sept. 27. Everyone launched from Appleton's Lutz Park and landed just over two hours later, 6.5 miles downstream at Kimberly's Sunset Point Park.

Along the way four lockages, courtesy of the Fox River Navigational System Authority, required sardine-like proximity for the 130 paddle craft, two 10-person voyageur canoes, and safety patrol boats from the Outagamie County Sheriff's Department and Appleton Fire Department.

The lock tender opened the valves and the water drained quickly, lowering us the six feet or so that in pioneer times would have been a rocky rapids. The lower Fox River drops about 170 feet in all from Lake Winnebago to Green Bay.

During July's Park-to-Park paddle, the locks drew a lot of attention due to the need to portage around the disabled Menasha lock, which has since been repaired. During the Locks Paddle, the four locks operated flawlessly, to zero fanfare

Once the water level is equalized with the river downstream, the tender grips a steel rod and walks around and around the large gear assembly that opens the lock's individuals. I'm especially pleased to say that 307 of those were first-timers for our

events, and 47 were younger than 16

years of age. It is wonderful seeing the youth participate!

I was traveling in one of the voyageurs, owned by the Wisconsin Department of Natural Resources, but loaned out to us for several paddles. Before I knew it, we were racing Mark Gehrke's voyageur-for-hire, the good ship Nature Current, for the landing in Kimberly. The boats of many styles and colors landed at the concrete boat ramp. As always, paddlers helped each other haul boats and gear; then loaded up and drove off back to their lives.

PROPOSED BOAT TRANSFER STATION AT RAPIDE CROCHE TO OPEN WATERWAY FOR **BOATERS FROM** GREEN BAY TO LAKE WINNEBAGO

Station Offers Best Science Available for Keeping Aquatic Invasive Species Out of Lower Fox and Winnebago Pool Lakes, While Increasing Boater Compliance

KAUKAUNA, Wis., (November 14, 2014)

The Fox River Navigational System Authority (FRNSA) process, compliance is very low. is announcing plans to build a boat transfer and cleansing Bay to the Winnebago Pool Lakes for commerce and future of the Fox River System, is partnering with FRNSA recreational boating. Planned for 2017, the proposed boat to get the word out to the general public. transfer station will greatly diminish the current threat of aquatic invasive species (AIS) from impacting some of Wisconsin's most valued fisheries. It also enables boaters to be compliant in cleaning their boats and equipment, while protecting the waters from harmful hitchhikers.

The boat transfer system works by lifting boats into the transfer station, where they are high pressure-washed with 110-degree water to dislodge any organisms adhering to the hull, and then lowered into a 112-degree water cleansing operated and flushed before being placed back into the installed at strategic points around the Winnebago Pool Lower Fox upstream of the transfer station. Studies Lakes system. completed by Dr. Bart De Stasio, at Lawrence University, concluded that the Rapide Croche boat cleansing process meets performance standards, can cleanse watercraft in a minimum amount of time and is an efficient, effective and safe way to keep AIS out of the Lower Fox and Winnebago Pool Lakes.

"This is the best science available for preserving and effectively protect the river system, while allowing of AIS prevention. navigation through an historic river and canal system.

will be refurbished by 2015. The Rapide Croche lock must remain closed in accordance with Wisconsin Statute 237, which requires a solid barrier be in place to prevent sea lamprey and other AIS from moving upstream. Without the boat transfer station, the greatest risk for AIS to enter the Lower Fox currently comes from boats, trailers, and equipment that are moved from place to place, and primarily from anglers who fish on the Great Lakes. There are more than 100 boat landings for boaters to enter the Pool Lakes. When the boat transfer station is completed, boaters will be able to trailer to Rapide Croche and have FRNSA's trained staff do the cleansing for them.

Organizations like Stop Aquatic Hitchhikers recommend a rigorous cleansing process before boaters trailer to a new location. It is recommended that boaters remove all visible mud, plants, and fish from their boats as well as clean and dry anything that has come in contact with water. The entire process can take up to five days to be completely safe. Due to the multi- faceted cleansing process and the length of the
